**Servizi Italia: notification of share buy-back

Servizi Italia S.p.A. informs that, in the period between 16 May and 20 May 2022 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2021 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 20,242 ordinary shares (corresponding to 0.064% of the Company's share capital) at an average price of Euro 1.6291 per share, for a total of Euro 32,975.44.

Details of all buyback transactions on the Euronext Milan Market in the period between 16 May and 20 May 2022 are enclosed.
