Servizi Italia S.p.A. informs that, in the period between 3 July and 7 July 2023 the Company bought on the Euronext Milan Market, pursuant to the resolution passed at the Shareholder's Meeting held on 20 April 2023 (previously communicated as per Art. 144-bis of Consob regulation 11971/1999), n. 5,050 ordinary shares (corresponding to 0.016% of the Company's share capital) at an average price of Euro 1.3308 per share, for a total of Euro 6,720.75.

Details of all buyback transactions on the Euronext Milan Market in the period between 3 July and 7 July 2023 are enclosed.
